Mandatory Safety Precautions

Dress code for Riding:

Student Rider's and Guests will be required to ride in proper outfit consisting of a pair

- Riding Helmet is compulsory (Student Rider's) or club Helmet available(Guest).
- Stretchable jeans pants preferably riding breeches or jodhpurs.
- Any closed shoes with heels are acceptable. Riding boots of leather/rubber are preferred.
- **NO** sandals/crocks or heel less footwear is permitted for safety reasons.
- Body protectors are optional depending on the parent's choice.

GENERAL RULES:

Rights of admission reserved. Subject to availability of resources.

1. All Student Riders/ Parents must read and sign the "Indemnity Form" and understand that equestrian Sport and horsemanship is a high risk activity.
 2. All Student Riders are advised to take adequate insurance at their own cost, as this is a high risk sport .Sky wings Equestrian Academy will not be responsible for any injury.
 3. The objective of Sky Wings Equestrian Academy is to impart to its students a good foundation in equestrian & horsemanship skills through proper instruction, coaching and training.
 4. Student Rider's are expected to participate in in-house equestrian sport shows, which will serve as an assessment of their skill and progress, as well as in all of the planned activities that serve to build up positive team spirit.
 5. Theory sessions, workshops, clinics are planned to further the education of the Student Riders.
 6. Student Riders are expected to take part in these.
 7. All Student Riders are required to participate in In-house Shows and Programs, which will serve as an assessment of their riding skills.
 8. A vital part of the learning of this sport is an understanding and sensitization towards horses. Student Riders are encouraged to further their education through practical, hands-on interaction, communication and bonding with horses through stable management.
 9. In-house activities like games, movies Shows, quiz contests etc. Are activities that bring riders together in a social atmosphere. Student Riders are expected to be present and actively participate in these and to volunteer assistance in areas that they are able to help out.
 10. All Student Riders / Students should be Subject to the discipline of the Institute and maintain Cordial relationships with other riders and staff.
 11. a) Student Riders/ Students shall abide by the instructions given by the Riding Instructor or the Coach of the Sky wings
 12. Horse riding School regarding the horse / pony that is allocated for the ride.
 13. No Student Riders sit or ride alone, except as per the instruction of the Riding instructor.
 14. Individual Schooling programs given to riders to follow must be adhered to and should not be deviated from by any other activity, riding or otherwise. Individual feedback to be reported to the Instructor or riding school manager after each such ride.
 15. The Student Riders / Students/ Guests are themselves entirely responsible for any injury or Accident that may occur
 16. to them while riding or in the stable area or while participating in other activities connected with horses and will not claim form Skywings horse Riding School or its officials and staff any compensation whatsoever.
